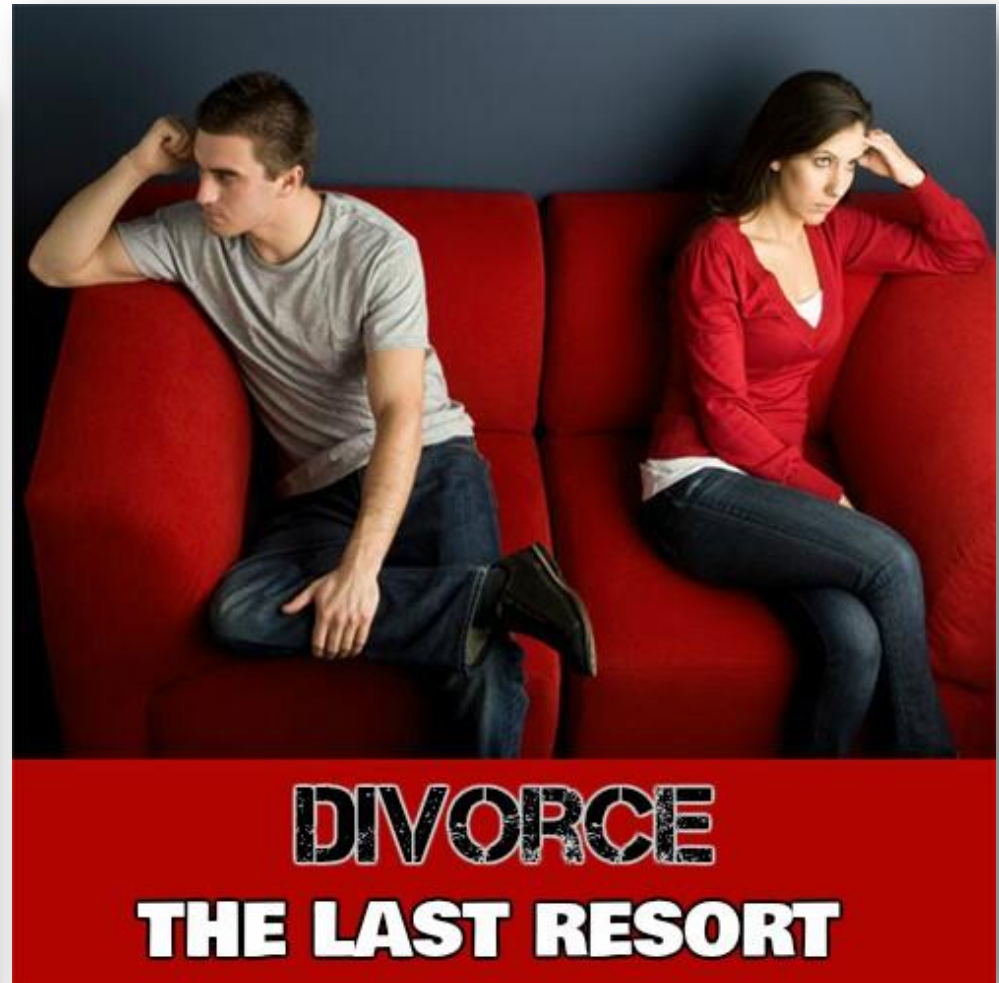

DIVORCE: THE LAST RESORT

Chances are, we all know someone who is divorced - probably several some ones. The U.S. Census Bureau says that 50 percent of all marriages entered into today will end in divorce. That's a lot of broken homes, heartaches and paperwork, not to mention money spent on attorney fees and court costs.

But, some say those percentages of future doomed marriages have to be interpreted based on other factors. Barbara Whitehead and David Popenoe's "The State of Our Unions," which was prepared at Rutgers University for the National Marriage Project, says that there are several important social factors that affect that 50 percent estimate. For example, your risk of divorce decreases by:

- 30 percent if your annual income is more than \$50,000
- 24 percent if you had a baby more than seven months after you got married
- 24 percent if you were over 25 when you got married
- 14 percent if your own parents never divorced
- 14 percent if you go to church as a family
- 13 percent if you attended some college

PARENTING THROUGH DIVORCE

1 - RELEVANCE OF DIVORCE TO CHILDREN

There are few adults and parents who are not aware of the challenges and potential difficulties that divorce imposes on children. Divorce is no longer an uncommon occurrence in most countries of the world. While countries in North America tend to have higher divorce rates than other developed and developing countries, there are still some common trends and numbers to divorce around the world.

PREVALENCE OF DIVORCE

It is estimated that the overall divorce rate in the United States is approximately 51% and in Canada it is 48%; Japan's divorce rate is about 27%, Australia is around 40% and Great Britain has a divorce rate of about 38%. The number of divorces per year tends to be increasing in many areas, with second and subsequent marriages having a higher overall divorce rate than first marriages.

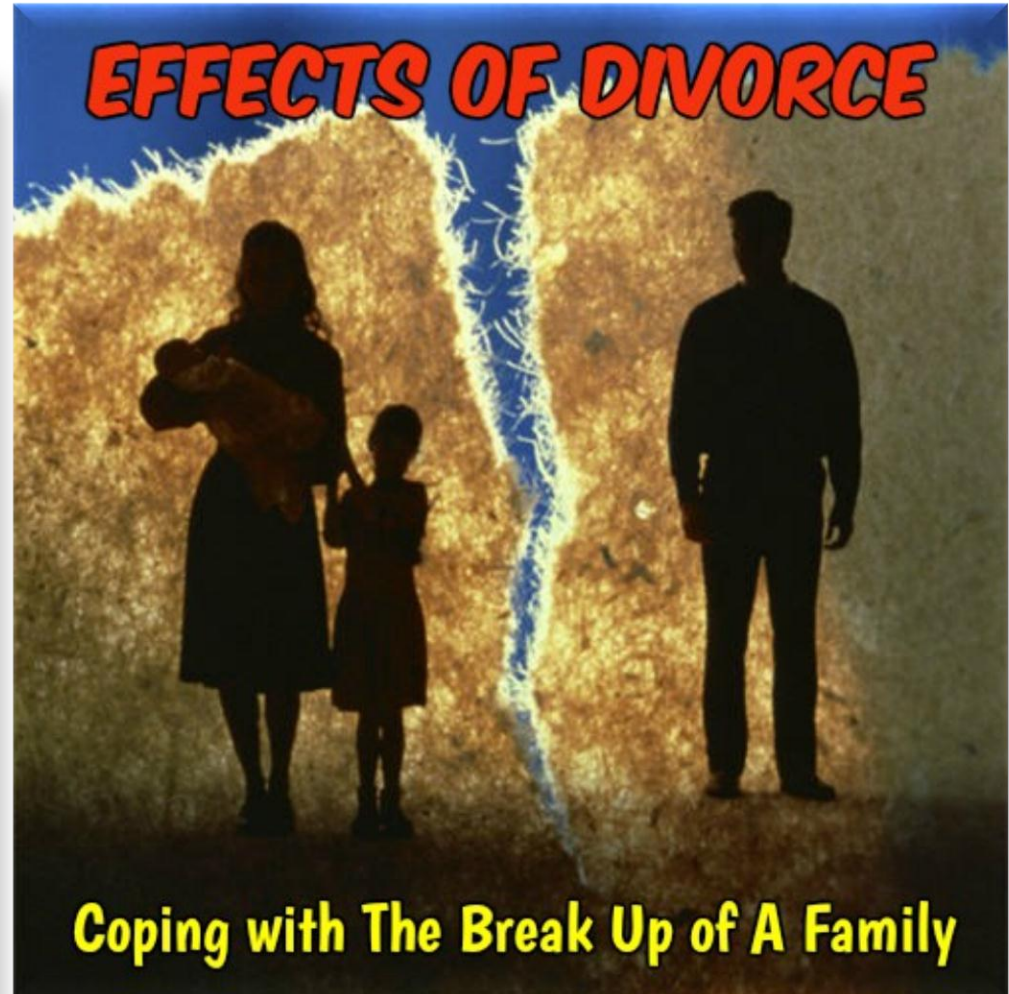

Divorce and Effect:

It's Emotional, Physical, Financial and Societal Impact

Divorce is one of the most heart wrenching events an individual must endure. Considering that 40% of marriages in the United States end in divorce, it is a sad reality for millions of individuals.

The effect of divorce touches many areas of a person's life, such as emotional, financial, and physical. The financial aspect of divorce can be staggering. Divorce leads to two households existing on one income. When children are involved, even with child support, financial hardships usually arise. Women more often than men are granted custody of the children after a divorce. In some instances, this reduces their ability to secure high-paying employment.

Divorce may increase financial hardship when child support is not received, or the non-custodial parent does not feel that they have an obligation toward their children. The government does provide a welfare system for divorced parents and their dependent children; resulting in even harsher consequences of divorce and its effect on society as a whole.

Divorce and its Effect on the Whole Family

The grieving process that follows any loss happens in divorce as well. The dissolution of a marriage is a death of sorts and those going through a divorce grieve. Depression and anxiety often follow on the heels of a divorce and affect all parties involved, including the children of the union.

The physical implications of divorce are somewhat controversial. There have been studies that have shown a positive correlation between divorce and incidence rates of stroke, cancer, parasitic diseases, acute infectious diseases, and digestive and respiratory illnesses. It was even shown that married cancer patients are more likely to recover than cancer patients who were divorced. Overall, divorced men have lower life expectancies than married men. Divorce does have a physical impact, although to exactly what extent is hotly debated.

DIVORCE FACTS:

Fault And No-Fault Divorces

Divorce is a legal process in which one or both parties in a marriage can ask to have their marriage contract voided. There are a number of reasons why individuals may choose to obtain a divorce. Some of these reasons include infidelity, irreconcilable differences, physical or mental cruelty etc.

Sometimes divorces can be accomplished in a very civil manner, while other divorces may be very mean-spirited and vengeful. In addition, the accumulated assets of the divorcing couples are divided between the two individuals. Complicating factors could include custody battles and visitation rights of children born from the marriage.

Therefore, all of these variables have caused some court systems to embrace no-fault divorces. Knowing the difference between fault and no-fault divorce is an important differentiation to understand if you are considering divorce or are currently involved in divorce court proceedings.

What Is No-Fault Divorce?

No-fault divorce is a legal proceeding that results in the marriage between two individuals being terminated. This termination of the marriage can be initiated by either marriage partner.

In addition, this dissolution of the marital bonds can be pursued by the person requesting the divorce without having to give proof or evidence of any wrongdoing on the part of the other individual. Often the reasons that are stated, when requesting a divorce, can include such phrases as 'irreconcilable differences' or 'for reasons of incompatibility.'

Also, the divorce can be pursued by either member of the marriage despite any opposition raised by the other marital partner.

Fault Divorce

A fault divorce is also a legal proceeding that culminates in the dissolution of the marriage. However, a fault divorce requires the individual who is petitioning for a divorce to provide a reason for the request.

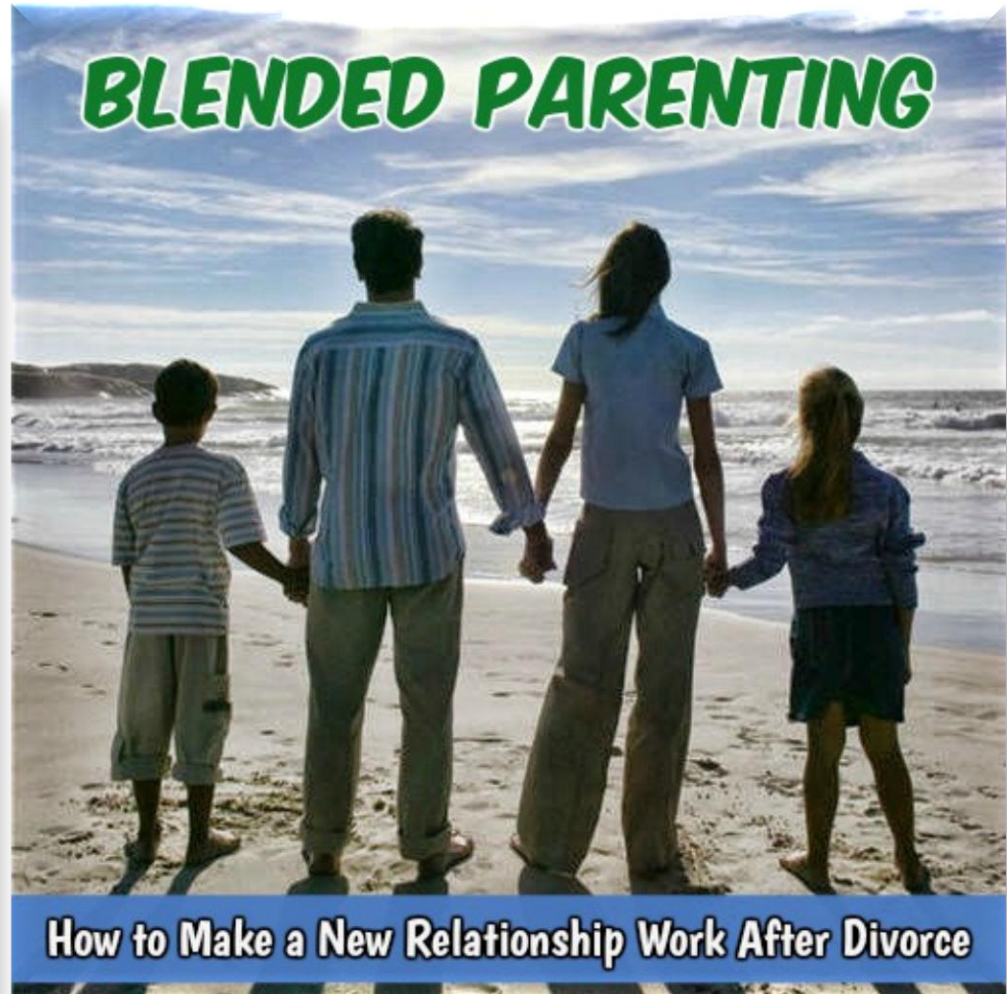

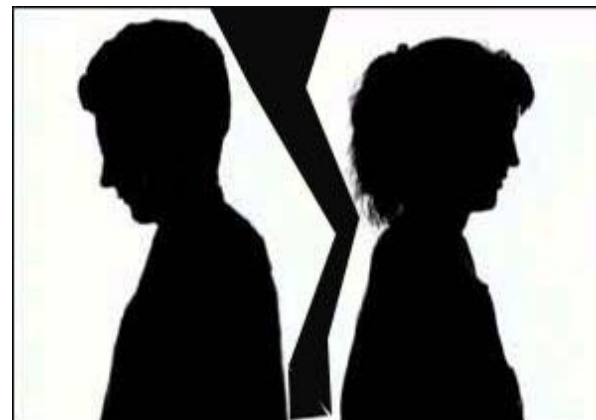
